Children must meet one of the following age criteria:

- Children ages 3 to 4 on September 1 of the current school year, or age 5 if not yet aged out of eligibility.
- Children ages 0 to on September 1 of the current school year, or age 5 if not yet aged out of eligibility, who
  meet one of the following criteria:
  - A parent of the child is under the age of 21 and currently pursuing a high school or general education equivalency diploma (GED)/hust also meet income eligibility requirements);
  - The child is in foster care or receivichgild protective services or
  - The familyhas experienced homelessness in the previous 24 md(mbst also meet income eligibility requirements)\*, or
  - The child has a sibling who has alreading on awarded a scholarship and attends the same program, long as funds are available pplications for eligible siblings do not require proof of income eligibility.

\*Note: Priority for funding is given to children who meet the eligibility criteria with an asterisk (\*).

Beginning January 1, 2024, age eligibility will expand to all children ages 0 to 4. Priority for scholarships will be given to children listed in the priority criteria above.

Note: Awards are made as long as funds are available be child is determined to be eligible for an early learning scholarship and funds are not available, they will be added to the waitlist.

## How do I Apply for arEarly Learning Scholarship?

- 1. Complete the application blue/blackink or electronicallyInformation that is required is marked with an asterisk(\*).
  - If the child is in foster care, the county or tribal social serviges aymust complete and sign the application. The foster parent cannot apply directly for a scholarship.
- Attach therequired documentation demonstrate your eligibility. See Pagef6r requirements for Option 1 (proof of participation in a publically fundendogram) or Page for requirements for Option 2 (proof of income).
  - If applying in the "parent under 21 eligibility category the applicant parent must provide written proof of their pursuit of a high school diploma or GED the letterhead of the education organization providing the course(s) f study the parent attends.
- 3. Read the Agreement to Comply with Requirements d Tennessen Warning.
- 4. Sign and date the application bulue/black inkor electronic signature.
- 5. Submit youroriginal application to the Area Administrator by following the instructions provided at the bottom of the Application Checklish the next page
